Call to Order

Aaron Lopez, President, called the regular business meeting to order at 10:02 a.m. central daylight time (OS 2.4.) Lisa Matthysse, Executive Assistant, called roll and determined that a quorum of directors was present (OS 5.5.) Mr. Lopez announced the Initial Public Comment Period. Mr. Lopez led the Pledge of Allegiance and the recital of Panhandle Community Services' mission statement. Magi York, Executive Director, led prayer.

Board Training (OS 5.8)

Magi York introduced Jason Sabo, founder of Frontera Strategy. Mr. Sabo gave a presentation on redistricting and how it may affect the Panhandle. He noted that the population shift over the last ten years has moved away from rural areas, such as the Panhandle, and towards large metropolitan areas in other parts of the state. He reviewed the current process in Texas for distributing federal funds, and said that Community Action Agencies should pay attention to the timeline of legislative sessions and funding. He said we should ask questions of our state representatives about all of the new federal money and about reassurances that our region is not left out. Mr. Sabo recommended working with agencies in other parts of Texas to ensure that matters important to rural areas are represented in the legislature. He mentioned working with the Rural Caucus, a group of legislators who speak up for rural interests, and foundations such as Texas Rural Funders, who have the needed infrastructure in place to work across multiple regions.

Healthcare Update

Kaitlin Mosley, RSVP Director, gave an update on her Healthcare Insurance Gap presentation from last month. Ms. Mosley referred to the "Medicaid Participation by County" spreadsheet (included in the packet.) She reviewed the highlighted areas that showed the statistics for counties in the Panhandle. She also reviewed information gathered by the Panhandle Regional Planning Commission (see the "Medicaid Enrollment and Uninsured" handout) which compared the statistics for the Panhandle compared to the rest of the state and the nation.
